2. Sell undergarments of any kind;
3. We have relaxed our policy on the sell of items not produced on white, red or cream background. But we ask that you be cautious in your production and sale of in any other colors.
4. Reproduce the Coat-of-Arms or the Fraternity's name without the appropriate trademark. ®
5. Sell items bearing other companies name/emblem/symbols that are not properly registered or authorized by appropriate company officials. [When vending at any Kappa Alpha Psi event.]
6. Sell in conjunction with Kappa paraphernalia, any items that have been reproduced illegally (Boot-Leg Cd's, DVD's, Video Tapes, etc.)
7. Manufacture, produce, or sell "paddles" (Unless in a manner approved by this office).
